

**PROCEEDINGS OF THE FRANKLIN COUNTY BOARD OF SUPERVISORS**

September 4, 2007

Be it duly noted these minutes of 9/4/07 are UNOFFICIAL minutes.

The Board of Supervisors met in regular session at 8:30AM with Board members Corey Eberling-Chairman, Jerry Plagge, and Michael Nolte present.

Motion by Plagge, seconded by Nolte, to approve the agenda as submitted. All ayes. Motion carried.

Motion by Nolte, seconded by Plagge, to approve the minutes of 8/27/07. All ayes. Motion carried.

The Board opened the meeting to public comment. Present were: Kirby Winter-IT Director, Earl Kalkwarf-Franklin County Sanitarian. Committee reports were on Community Action, Franklin County Development Association revolving loan fund and IMWCA annual meeting with department heads.

At 10:00 AM Kurtis Krause met with the Board regarding Joint Drainage District 4-53 on tile reroute and cleanout. Present were: Kurtis Krause-Iowa Falls, Jerry Lyon-Alden, Richard McNickle-Iowa Falls and Dennis Ziesman-Alden. Property owners expressed their need to get this problem repaired immediately so as not to lose another crop next spring. A bid was received from McDowell Inc. and the Board was asked from those present to receive bids from other contractors to determine if they had the time to get the repair done yet this fall. Brocka was contacted in Aredale and will look at the tile today or tomorrow.

Motion by Nolte, seconded by Plagge, to hire Ron's Roofing to shingle the Franklin County courthouse flat roof, to tear off the old shingles and replace with ice and water barrier at all eaves and valleys, 30# felt, valley metal and roof edging as needed with 50 year laminated shingles for \$64,500. The color of the shingles will be under advisement from the State Historical Society. All ayes. Motion carried.

The Board acknowledged the Franklin County Alcoholism Service Center Activity Report from June 21-August 20, 2007 and the Financial Statement for the period ending July 31, 2007.
